This rule is proposed to comply with the five-year rule review requirement and to update the Ohio Plumbing Code (OPC) to the 2021 International Plumbing Code (IPC) model code published by ICC. This new rule is being filed to replace a rescinded rule of the same rule number.

This rule prescribes the number of plumbing fixtures required and the specifications for the fixtures.

Due to the variance in allowed building designs, it is very difficult to ascertain, in dollars, a cost increase or decrease in the design cost of a building as a result of this proposed code update. Some changes result in a cost increase while others actually reduce the cost of construction. The board has carefully evaluated all of these changes and balanced any increases in cost with an added benefit of enhanced life safety to the building occupants or ease of maintenance of required systems.
