**Report of findings.**

- (A) Written report and recommendation. Upon due consideration of the evidence adduced at the hearing and the ~~closing~~ arguments made, ~~or briefs of the parties and the commission attorney~~, the ~~administrative law judge~~administrative law judge shall submit to the ~~commission~~ commission a written report setting forth findings of fact, conclusions of law and a recommendation of action to be taken by the ~~commission~~commission.
- (B) Objections. ~~A copy of the written report and recommendation of the administrative law judge shall be served on all parties and the commission's attorney no more than fifteen days after the filing of such report with the commission. Any party to a hearing and the commission's attorney may file and serve a written statement of objections to such written report and recommendation with the commission's central office compliance department. Written statements of objections shall be considered by the commission before approving, modifying or disapproving the administrative law judge's recommendation. Objections must be filed within twenty days from the date the administrative law judge's report was served. Responses to objections must be filed within fourteen days from the date the objections were served. Objections and responses to objections must be served on all parties. Any party or aggrieved person who has met the requirements of section 4112-3-07(C)(1) of the Administrative Code may file and serve a written statement of objections to such written report and recommendation to the commission's central office compliance department. Written statements of objections shall be considered by the commission before approving, modifying or disapproving the administrative law judge's recommendation. Objections must be filed within twenty days from the date the administrative law judge's report was served.~~
- (1) Any party or aggrieved person who has met the requirements of section 4112-3-07(C)(1) of the Administrative Code may file a written response to objections. A response to objections must be filed with fourteen days from the date the objections were served.
- (2) Objections and responses to objections must be filed with the compliance department of the commission at 30 E. Broad Street, 5th Floor, Columbus, Ohio 43215 and served on all parties.
- (C) Consideration of written report and recommendation. The ~~commission~~ commission shall consider the written report and recommendation of the ~~administrative law judge~~administrative law judge at any regular or special meeting . The ~~commission~~ commission may approve, modify, or disapprove the written report and recommendation of the ~~administrative law judge~~administrative law judge and shall issue its order accordingly.
