language requiring that employers provide reasonable and sufficient leave to pregnant employees irrespective of the terms and conditions on which leave is provided to other employees. This revision is consistent with the statutory provision which provides that pregnant women "be treated the same for all employment-related purposes" as other employees who are unable to work. In short, the proposed revision, like the statute, will ensure equal treatment of pregnant employees in the workplace.
