Specifically, the word "private" (referring to the type of housing) was struck and it was clarified only the interior of the dwelling unit needs to be restored to the original condition, if such is reasonable and agreed upon, per the statute. Also the phrase "disabled person" was changed to "person with a disability" per HB 281.
