The total number of new CPT and HCPCs codes is 584, with the number of current 2011 codes to be deleted totaling 181. There are no projected measurable changes in provider reimbursements. The codes changes would not impact execution of BWC's standard methodology and project plan for the normal annual evaluation and recommendation for the Professional Providers and Medical Services fee schedule.
