BWC's hospital inpatient reimbursement methodology is based on Medicare's "Medicare severity diagnosis related group" or "MS-DRG" methodology, which is updated annually. Therefore, BWC must also annually update OAC 4123-6-37.1, to

keep in sync with Medicare.

This rule establishes the fees to be paid by BWC to providers of inpatient hospital services for injured workers.

For inpatient services, BWC proposing the following for 2023:

Hospital Inpatient Reimbursement Rule:

- Adopt Medicare 2023 IPPS rule updates
- o 3.1% increase in the market basket (inflation)
- o Quality and value related program adjustments (pay for performance)
- Continue to offset Medicare legislative mandates, and
- Adopt a BWC payment adjustment factor (PAF) of 114.3% of the Medicare rate.

Implementation of fee schedule changes is a necessary part of yearly methodology updates for both hospitals and self insuring employers. Because this methodology is largely based on Medicare, both hospitals and self insuring employers will realize minimal adverse impacts. It is estimated that self insuring employers and hospitals would require less than 10 hours of programming time in order to comply with this rule.
