H.B. 67, effective June 21, 2005, transfers the operation and administration of the Public Employment Risk Reduction Program from the Department of Commerce to BWC. The bill also abolishes the Public Employment Risk Reduction Advisory Commission and abolishes the Public Employment Risk Reduction Fund.

The amendment to this rule is chiefly updating the rule language required by the transfer of PERRP from the Department of Commerce to BWC. For example, the rule strikes references to the labor and worker division and replaces the language with the safety and hygiene division.
