school bus" and clarify that every school bus shall be operated in compliance with the operation and safety rules established by the Ohio department of education in Chapter 3301-83 of the Administrative Code. Change to the rule title is also being proposed to include addition of the language "and operation" and replacement of the language "motor vehicle equipment" with "school bus".
