This rule filing is to coordinate with proposed change to rule 4501-1-10 which allows for staggered licensure by requiring that the licensee submit a required status report 60 days prior to the expiration of a private pupil transportation license rather than during the period currently set forth in the existing rule and to add section 4511.763 of the Revised Code as an amplifying statute.

The existing rule provides that a private pupil transportation licensee submit the required annual status report between September first and December first each year. Proposed new language accommodates implementation of a staggered licensing system as proposed in rule 4501-1-10 in requiring that a licensee submit the required annual status report 60 days prior to the expiration of a private pupil transportation license.
