This rule provides the definitions of terms used throughout the chapter related to advanced Juvenile driver improvement programs and other remedial programs. The proposed amendments include definitions for "Advanced Juvenile Driver Improvement Program," "Advanced Skills Instructor," "Chief Instructor," and "Range." Existing definitions were modified to include the advanced juvenile program and clarify definitions for "Juvenile Remedial Driving Course" and "year." Finally, paragraph (V) was added to address materials incorporated by reference in Chapter 4501-21.
