This rule addresses remedial driving course enterprise office requirements. This rule should not have a financial impact regarding the requirement for access to computers, printers, e-mail, and internet functions, as it allows for internet use via the public library. However, while current course enterprises that provide remedial driving courses via the classroom are already required to have offices, under this rule there could be a financial impact experienced by enterprises if changes are needed to assure there will be adequate office space to conduct necessary business. Also, if an enterprise has not previously obtained an office fire inspection as required by the proposed rule, there would be minimal related costs involved in obtaining an inspection. Also, there is one enterprise located in another state that is currently approved to provide technology-based training and under this proposed rule, it would need to locate an office in Ohio.
