This rule sets forth the character and fitness requirements for all persons associated with a remedial course enterprise including a course manager, a chief instructor an instructor, and an authorizing official. The proposed amendments add "chief instructor" as a person who must meet fitness and character requirements, require the authorizing official of a remedial course to provide information on legal proceedings filed against a remedial course, and include the convictions of "any person" associated with the remedial course to be grounds for denying, suspending, or revoking approvals or applications.
