Paragraph (H) requires a remedial driving course enterprise to notify the director in writing of legal action that is filed against or by the enterprise, its officers, any owner, or any instructor arising from the enterprise's failure to perform or operate its courses safely, after the school, its officers, any owner, or any instructor has commenced the legal action or has been served with legal process. This filing increases the time allowed for notifying the department regarding legal action from five to ten days.

This rule's requirements would apply to all remedial driving course providers, including currently approved enterprises, at the time of their application for initial Department approval under the proposed new rules of OAC Chapter 4501-21. This rule clarifies existing requirements regarding character and fitness and we therefore do not anticipate that this rule will increase the cost of compliance. However, this rule prohibits the involvement of people with specified criminal histories from being connected with remedial driving courses and in Rule 4501-21-05 there is a related requirement which provides that all authorizing officials must submit criminal background information with applications for initial approval. (Maximum cost for a Bureau of Criminal Investigations criminal background check is \$35 - See the fiscal response information for proposed Rule 4501-21-05 which addresses application for, and renewal of, remedial driving course approval.)
