This rule is being filed to implement statutory changes set forth in SB19, 129th General Assembly, which incorporate advanced juvenile driver improvement courses into the remedial driving course program.

This rule sets forth the course curriculum requirements and length of the programs for adult remedial, juvenile driver improvement, and the advanced juvenile driver improvement. The proposed amendments address the materials incorporated by reference and the hours and specific topics required for the advanced juvenile improvement program.

A.) Does this rule require a license, permit, or any other prior authorization to engage in or operate a line of business? **Yes**

Yes, this rule requires the approval of proposed curriculum to be used by an adult remedial driving course or an advanced juvenile program at application and the appropriate program approval issued by the director of the department of public safety prior to engaging in instruction of remedial courses.

B.) Does this rule impose a criminal penalty, a civil penalty, or another sanction, or create a cause of action, for failure to comply with its terms? **Yes**

Yes, remedial course approval applicants may be denied and an approved program may be subject to administrative action if the proposed curriculum fails to meet the requirements established in this rule.

C.) Does this rule require specific expenditures or the report of information as a condition of compliance? **Yes**

Yes. This rule requires that each enterprise applying for remedial course approval submit a proposed curriculum that meets the requirements of this rule at the time of application. Further, once approved, each remedial driving course enterprise shall maintain records that demonstrate that all instructors have been properly trained in use of the curriculum.
