This filing is one of a group of proposed amendments to Ohio Administrative Code Chapter 4501-21 that were prompted by and are based on provisions of recently enacted HB 67 (127th GA).

This rule sets forth requirements for remedial driving course record keeping, issuance of certificates of completion, and providing students with an opportunity to provide course evaluation. New language provides that for students who complete an approved adult remedial driving course that includes instruction through technology-based method(s), the classroom provider will issue the certificate of completion to the student upon verification of student completion of the approved eight hours of training. It provides that such certificate is provided by the department via the on-line certificate system.
