This rule sets forth the records to be maintained by a remedial course program and the information that is to be captured in those records. The rule also addresses the issuance and availability of the certificates of completion. Proposed amendments address materials incorporated by reference.

This rule is expected to increase the agency's revenues by \$4 per each certificate that an advanced juvenile driver improvement course issues. The net impact to the agency's budget during the current biennius is difficult to determine. The program is new and the number of students taking the course has not been determined.

The incurred costs associated for the providers of the advanced juvenile remedial program would be the \$4 per certificate of completion. The total costs for

certificates are determined by the number of students completing the advanced juvenile driver improvement program. Since the advanced juvenile program is new, the actual cost to a provider is difficult to determine.

Estimates were provided by the advanced juvenile driver improvement program committee comprised of Mark Bloom (Bloom's School of Driving Dynamix), Steve Bidlack (Mid-Ohio), John Phillips (Honda Transportation Research Center), Ken Stout (DriveTeam) and Jeff Caldwell (Professional Driving Systems Driving School). The current traditional juvenile driver improvement providers included Sharon Fife (D&D Driving School) and Peggy Mooney (Wyandot's Remedial Program).

This rule, in and of itself, does not require the authorization to engage in business. This rule, in and of itself, does not impose a penalty or sanction. However, failure to meet the requirements set forth in this rule, the approval of a remedial driving course may be subject to administrative action up to and including revocation of the approval.

condition of compliance? Yes

Yes. This rule requires that the remedial course maintain specific records. This rule also requires any remedial course to report any issues with the certificates of completion that would give concern of a violation. The rule addresses evaluations completed by the students so that the department may ascertain the effectiveness of the remedial program.

The rule requires a certificate of completion for each student successfully completing the program. The cost for such certificate is \$4 for each.
