This rule filing is based on a scheduled R.C. 119.032 five-year review of Ohio Administrative Code Chapter 4501-23. A rear-view mirror standard is currently included in the Administrative Code chapter that addresses motor vehicle inspections. For clarification and convenience of the public, manufacturers, importers and dealers in obtaining motorized bicyle equipment requirements, this new rule is proposed to address such a rear-view mirror standard specifically for motorized bicycles.

This rule requires that every motorized bicycle shall be equipped with a mirror so located as to reflect to the operator a view of the highway to the rear of such vehicle. It provides that the operator shall have a clear unobstructed view to the rear of the vehicle by mirror.
