This rule describes circumstances under which license plates issued to a registrant

by the state of Ohio need to be replaced. This amendment removes the reference to the blue and white plate previously issued by the BMV being obsolete, as the plate has been declared obsolete since September 2001. The amendment also removes reference to the "Gold" license plate as roadworthy provided it is in serviceable condition, and, instead, specifies that any plate issued by the state of Ohio that has not yet exceeded its useful service life may continue to be displayed until it is lost, mutilated, or destroyed; becomes illegible; loses its reflectivity; or is declared obsolete under this rule, provided that the plate also displays a current and valid validation sticker and county identification sticker
