The rule sets forth the required equipment for snowmobiles, off-highway motorcycles, and all-purpose vehicles. The rule amendments remove language mandating one working headlight and one working red tail light for the snowmobiles, off-highway motorcycles, and all-purpose vehicles because the same language is stated in the Ohio Revised Code. The rule amendments also remove language mandating muffler systems for the snowmobiles, off-highway motorcycle, and all-purpose vehicles.
