The estimated costs of compliance for stakeholders include any fees that may be charged by the local jurisdictions for completing an inspection or having to obtain a special permit in order to operate such vehicles on local roadways. For customers who choose to operate such vehicles they must apply for a certificate of title and register the vehicle with the Bureau of Motor Vehicles (BMV), thus incurring costs. Costs would vary for certificate of title and registration fees based on the county of residence of the customer.
