Pursuant to Revised Code 5502.11 every law enforcement agency representing a township, county, municipal corporation, or other political subdivision

investigating a motor vehicle accident is required, within five days, to forward to the director of public safety a written report of such accident. Such report is to be on a form which the director shall prescribe. This rule provides for the form and contents of the report to be known as the "Ohio traffic crash report," assigned the form number "OH-1" and provides related definitions. It also clarifies that the registrar of motor vehicles shall prescribe whatever form may be necessary to report motor vehicle accidents to the bureau of motor vehicles for financial responsibility purposes pursuant to Chapter 4509. of the Revised Code and that the registrar may authorize the use of a copy of the "Ohio traffic crash report" as part of the reporting requirement or may prescribe other forms.
