Proposed changes are to provide language corrections, to update, clarify and reorganize rule language, to correct grammatical errors, to remove unnecessary language, to specify the date of the versions of the federal regulations and other texts incorporated by reference throughout OAC Chapter 4501-5, to provide a list of contact sites for the material incorporated by reference in OAC Chapter 4501-5, and to clarify that earlier versions of Ohio school bus minimum construction standards incorporated in this rule will be deposited in five depository libraries when those libraries have been designated by the State Library Board under R.C. 3375.01 and that in the meantime these standards are available via the address

provided in the rule for the Ohio Highway Patrol.

The rule includes general provisions regarding school bus construction standards including: effective date of rules, school bus definitions, notification requirements regarding recall of any safety-related products, compliance documentation required of manufacturers, procedures regarding any changes in design or equipment of school buses, requirements for chassis and body replacement parts, responsibility for school bus construction standard compliance, and requirements for any composite materials used in school bus construction.

Proposed changes correct rule verbiage, clarify and reorganize rule language, correct grammatical errors, delete unnecessary language, specify the date of the versions of the federal regulations and other texts incorporated by reference throughout OAC Chapter 4501-5, update rule language to national school transportation specifications and procedures, provide a list of contact sites for the material incorporated by reference in OAC Chapter 4501-5, add definitions, address applicability of OAC Chapter 4501-5, and provide that copies of earlier school bus construction standards will be deposited in five depository libraries once those libraries have been designated by the State Library Board and that in the meantime, these earlier school bus constructon standards are available via the address provided for the State Highway Patrol.

To remain current and in compliance with all federal and the applicable safety and equipment requirements and guidelines, school bus manufacturers and owners (the persons who reasonably can be expected to be affected by the rules of OAC Chapter 4501-5) already stay abreast of the industry standards incorporated by reference in OAC 4501-5 (industry standards include those of the Society of Automotive Engineers, the American Society for Testing and Materials and the National School Transportation Specification and Procedures). Additionally, we have provided the address, telephone number, and when applicable, web site information for these organizations.

While Rule 4501-5-01 also incorporates federal regulations and R.C. Section

This rule also incorporates by reference Revised Code and Ohio Administrative Code information however, such information is excepted by R.C. 121.76 from the referencing requirements of R.C.121.71 to 121.75.

This rule incorporates earlier versions of Ohio school bus minimum construction standards in effect on the bid date, or if bid date is unknown, on the manufacture date of older buses. These standards are currently available in printed form and most Ohio schools and bus manufacturers already have copies of these standards. The standards are lengthy and would require a large expenditure of time to reproduce electronically. The standards will be deposited in five depository libraries when those libraries have been designated by the State Library Board under R.C. 3375.01. In the meantime, these standards are available via the State Highway Patrol Licensing and Commercial Standards Section, 1970 West Broad Street, Columbus, Ohio 43223.
