This filing is based on a R.C.119.032 rule review of Ohio Administrative Code Chapter 4501-5. Proposed changes are to clarify the definitions for "Type A" and "Type B" school buses, to adjust the gross vehicle weight ratings of "Type A-I and Type A-II school buses, and to update equipment requirements to align the Ohio standards with national and industry standards. Other changes are to improve rule clarity, to add to and to clarify the applicable versions of incorporated standards, and to correctly identify the numbers of referenced rules as they are reorganized in this filing of OAC Chapter 4501-5.

This rule includes general provisions regarding school bus construction standards including: effective date of rules, school bus definitions, notification requirements regarding recall of any safety-related products, compliance documentation required of manufacturers, procedures regarding any changes in design or equipment of school buses, requirements for chassis and body replacement parts, responsibility for school bus construction standards compliance, requirements for any composite materials used in school bus construction, and contact site addresses, websites, and telephone numbers for obtaining materials incorporated by reference in Chapter 4501-5 of the Administrative Code. This rule also provides information for obtaining earlier versions of Ohio school bus construction standards in effect on the bid due date, or if the bid date is unknown, on the manufacture date of older buses.

Proposed changes include clarification of the definitions for "Type A" and "Type B" school bus, updates to increase the gross vehicle weight ratings in the definitions for Type A-I and A-II school buses, addition of a definition of the term "manufacturer's rated seating capacity," clarification of the version of the Federal Motor Vehicle Safety Standards incorporated in the rules of OAC Chapter 4501-5, changes to the numbers of referenced rules to reflect their reorganization and renumbering in this filing of OAC Chapter 4501-5, and an added provision in paragraph (O)(2) that provides clarifying information regarding applicable versions of school bus construction standards.
