This rule is being filed according to a scheduled five-year R.C. 119.032 rule review. This rule is also proposed for simultaneous rescission and adoption under this same rule number due to the Legislative Service Commission's rule-formatting guidelines, as it is estimated that more than fifty percent of the rule's content has been revised.

4501-5-01 sets forth the general provisions regarding the purpose of Chapter 4501-5; chapter definitions; requirements for compliance to Chapter 4501-5; requirements for notices of compliance, changes to equipment, and recalls to be submitted to the director of public safety; documentation to be provided to purchasers of school buses; and materials incorporated by reference.

This rule is simultaneously proposed for rescission and adoption under this same rule number.

This rule requires manufacturers, dealers, and owners, who wish to install equipment on school buses other than that which is specified in Chapter 4501-5 of the Administrative Code, to obtain approval from the director of public safety in writing prior to its use and operation.

Section 4511.761 of the Revised Code provides that all school buses shall pass inspection and display current inspection decals prior to being authorized for use to transport students.

B.) Does this rule impose a criminal penalty, a civil penalty, or another sanction, or create a cause of action, for failure to comply with its terms? Yes

This rule is simultaneously proposed for rescission and adoption under this same rule number.

This rule provides that a manufacturer's and/or dealer's failure to comply with Chapter 4501-5 of the Administrative Code may result in the suspension of authorization for the sale and/or use of the school bus chassis and/or body in the state of Ohio until the violation is corrected.

Paragraph (C) of section 4511.76 of the Revised Code provides that whoever violates Chapter 4501-5 of the Administrative Code is guilty of a minor misdemeanor, while subsequent violations are misdemeanors of the fourth degree.

C.) Does this rule require specific expenditures or the report of information as a condition of compliance? Yes

This rule is simultaneously proposed for rescission and adoption under this same rule number.

This rule sets forth the requirement for school bus manufacturers to file a statement of compliance with the director of public safety that all products and components manufactured for use in Ohio school buses comply with division (F) of section 4511.01 of the Revised Code and Chapter 4501-5 of the Administrative Code, provide purchasers with written documentation specifying warranty provisions and a documented delivery list, and request permission to use/install any equipment or product, other than those specified in Chapter 4501-5 of the Administrative Code, in writing.

Further, this rule requires school buses to meet, and be maintained in compliance with, the standards set forth in Chapter 4501-5. As these standards are provided in rules 4501-5-02 and 4501-5-03, the estimated costs of compliance are provided in their RSFAs.
