This rule is being filed pursuant to a R.C. 119.032 review. This rule is proposed as new, while simultaneously proposed for rescission due to the fifty percent guideline. It is estimated that changes to the rule strike approximately half of the existing text, while adding a comparable amount of new text.

This rule provides the definitions of terms used throughout Chapter 4501-54 of the Administrative Code related to mature operator courses. The proposed amendments define terms related to mature operator courses including authorizing officials, enterprise, director, written exercise, skills demonstration and course instructor. A new paragraph has also been added to address materials incorporated by reference in Chapter 4501-54.

To comply with sections 121.71 to 121.74 of the Revised Code, paragraph (M) of this rule specifically addresses the dates/versions and availability of all materials incorporated by reference in Chapter 4501-54 including the following: "Mature Driver Course Completion Certificate," "Mature Operator Course Place of Business Supplement" and "Mature Driver Course Provider Application."

The incorporated materials are generally available via the Driver Training Program website at <http://www.drivertraining.ohio.gov/schools.htm> or its database application via <https://www.dps.state.oh.us/DriverTraining> to driver training enterprise course operators, course instructors, and authorizing officials, who are those persons who reasonably can be expected to be affected by the rule.

To comply with sections 121.71 to 121.74 of the Revised Code, paragraph (M) of this rule specifically addresses the dates/versions and availability via the Driver Training Program website or its database application of all materials incorporated by reference in Chapter 4501-54 including the following: "Mature Driver Course Completion Certificate," "Mature Operator Course Place of Business Supplement" and "Mature Driver Course Provider Application."

With the exception of the "Mature Driver Course Completion Certificate," which is numbered, tracked, and issued via <https://www.dps.state.oh.us/DriverTraining> to mature operator training programs only as requested, the materials are being filed

as part of this rule for the entire package.

This rule sets forth the definitions of Chapter 4501-54 of the Administrative Code. This rule, in and of itself, does not require prior authorization to engage in business. However, while filed as part of this package, it does, as some provisions in Chapter 4501-54 require the Department to approve all mature operator motor vehicle accident prevention courses, as well as all prevention course operators, prior to their operation of motor vehicle prevention courses.

B.) Does this rule impose a criminal penalty, a civil penalty, or another sanction, or create a cause of action, for failure to comply with its terms? **No**

This rule sets forth the definitions of Chapter 4501-54 of the Administrative Code, and therefore, in and of itself, it does not impose a penalty or sanction. However, while filed as part of this package, it does, as some provisions in Chapter 4501-54 establish that the Department may impose an administrative action up to and

including the withdrawal of approval to operate mature operator motor vehicle accident prevention courses, should the course not meet the requirements established in Chapter 4501-54.

C.) Does this rule require specific expenditures or the report of information as a condition of compliance? **No**

This rule sets forth the definitions of Chapter 4501-54 of the Administrative Code, and therefore, in and of itself, it does not require specific expenditures or the report of information. However, while filed as part of this package, it does, as some provisions in Chapter 4501-54 require applicants for course approval to make application in writing and provide detailed information regarding course curriculum, examinations, and course records.
