This rule is being filed subsequent to a R.C. 119.032 review. This rule is proposed as new, and simultaneously proposed for rescission due to the fifty percent guideline. It is estimated that changes to the rule strike approximately half of the existing text, while adding a comparable amount of new text.

This rule provides examination and evaluation requirements for mature operator courses. Changes in this new rule include modifications of the words "written examination" and "practical examination" to "written exercise" and "skills demonstration." The rule now includes the off-road range requirements to further clarify the expectations if the course uses this type of skills demonstration. The rule also includes further clarification of the evaluation questions to clearly distinguish what is expected for each participant to demonstrate proper techniques during the skills demonstration.

This rule sets forth the the examination and evaluation requirements for mature operator motor vehicle accident prevention courses. This rule, in and of itself, does not require prior authorization to engage in business. However, while filed as part of this package, it does, as some provisions in Chapter 4501-54 require the Department to approve all mature operator motor vehicle accident prevention courses, as well as all prevention course operators, prior to offering the courses.

B.) Does this rule impose a criminal penalty, a civil penalty, or another sanction, or create a cause of action, for failure to comply with its terms? **No**

This rule sets forth examination and evaluation requirements for mature operator motor vehicle accident prevention courses. This rule, in and of itself, does not not impose a penalty or sanction. However, while filed as part of this package, it does, as some provisions in Chapter 4501-54 establish that the Department may impose an administrative action up to and including the withdrawal of approval to operate a motor vehicle accident prevention course, should the course not meet the requirements established in Chapter 4501-54.

C.) Does this rule require specific expenditures or the report of information as a condition of compliance? **No**

This rule sets forth the examination and evaluation requirements for mature operator motor vehicle accident prevention courses. This rule in and of itself, does not require specific expenditures or the report of information. However, while filed as part of this package, it does, as some provisions in Chapter 4501-54 require applicants for course approval to make application in writing and provide detailed information regarding course curriculum, examinations, and course records.
