This rule is filed based upon a five-year R.C. 119.032 rule review prompted by legislation which transfers jurisdiction over driver education courses in high schools from the Department of Education to the Department of Public Safety. Rule amendments are to provide clarification regarding the required time frames for record keeping and the information required to be maintained by an enterprise or organization that completed training of instructors and training managers, to

address use of photographs, to provide that instructor candidates completing the forty-hour training requirements may student teach with the training manager supervising from the back seat, and to require that an applicant for a driver training manager license demonstrate that the applicant has held a valid class "D" driver training instructor license for at least three years.

The rule provides requirements for application and renewal of licenses for driver training instructors and driver training managers. New language clarifies the time frames for record keeping and the information required to be maintained by an enterprise or organization that completed training of instructors and training managers (Similar new language is also being proposed in Rule 4501-7-13), addresses use of photographs, provides that instructor candidates completing the forty-hour training requirements may student teach with the training manager supervising from the back seat, and requires that an applicant for a driver training manager license demonstrate that the applicant has held a valid class "D" driver training instructor license for at least three years.

With this rule we expect an increase in revenues in an amount of up to \$1500. The amount reflects an anticipated 150 maximum new instructor applications with application fees of \$10 per instructor. These are the instructors who are currently under the jurisdiction of the Ohio Department of Education and are being transferred to the jurisdiction of the Department of Public Safety. This increase is not expected to have a significant impact on the Department budget.

While the change in jurisdiction from the Department of Education to the Ohio Department of Public Safety involves costs, implementing this rule is not expected to impact the agency budget beyond the cost stated in Rule 4501-7-01 (This is the cost associated with printing updated driver training rules). Any changes requiring staff time will be accomplished by existing personnel and we therefore do not expect this rule to have a significant impact on the agency budget.

15. Provide a summary of the estimated cost of compliance with the rule to all directly affected persons. When appropriate, please include the source for your information/estimated costs, e.g. industry, CFR, internal/agency:

While new rule language clarifies that records regarding training of instructors and training managers must be maintained for three years, if a school is not currently meeting the requirement, there could be minimal costs with associated record keeping. For driver training enterprises that are being brought into the jurisdiction of the Department of Public Safety from the Department of Education, the \$10.00 per instructor renewal fee each year will be a new expense, as well as the \$25.00 initial application fee for new instructors and training managers hired after the initial agency changeover. The following application items also involve new expenses: requirement for two photos (approximately \$5.00 in cost), requirement for a driving abstract (\$2.00 in cost), requirement for disability certification, if determined necessary at an estimated cost of approximately \$715.00 reflecting \$250 for disability course fee, approximately \$225.00 for travel (variable), approximately \$240.00 for salary, and the requirement for continuing education every three years (approximately \$100 which is the cost of the course most commonly taken, plus, depending on course location, possible travel costs of \$225.00 (variable), and an estimated \$240.00 for salary.
