This rule filing is based on a five-year, R.C. 119.032 rule review of Ohio Administrative Code Chapter 4501-7. Proposed amended changes are to update terminology and to ensure that disability endorsed instructors remain up-to-date in their specialty training. Proposed expansion of the rule title is to enhance description of the rule content. Proposed changes include a language change to improve clarity ("persons" replaced by "beginning drivers") and to comply with LSC referencing requirements (see paragraph (B)(1)).

This rule provides the school requirements and instructor qualifications for instructing persons with a disability. In paragraph (A) the sentence "To maintain such endorsement, any disability endorsed instructor shall take a continuing education course approved by the director every three years" is proposed for addition. Further, a proposed change expands the rule title. Proposed changes include a language change to improve clarity ("persons" replaced by "beginning drivers") and to comply with LSC referencing requirements (see paragraph (B)(1)).
