This rule is filed based upon a five-year R.C. 119.032 rule review prompted by legislation which transfers jurisdiction over driver education courses in high schools from the Department of Education to the Department of Public Safety. New language is to provide clarification regarding the time frames for record keeping and the information required to be maintained by an enterprise or organization that completes training of instructors and training managers. It also is to provide clarification that a parent or legal guardian's signature may be accepted in lieu of the student's signature on a request for a new certificate of completion due to a loss

or theft of such certificate.

The rule provides requirements for records that are to be retained by driver training schools. New language provides the time frames for record keeping and the information required to be maintained by an enterprise or organization that completes training of instructors and training managers. (Similar language is also being proposed in Rule 4501-7-05.) Another change adds language to provide that a parent or legal guardian's signature may be accepted in lieu of the student's signature on a request for a new certificate of completion due to a loss or theft of such certificate.

While the change in jurisdiction from the Department of Education to the Ohio Department of Public Safety involves costs, implementing this rule is not expected to impact the agency budget beyond the cost stated in Rule 4501-7-01 (This is the cost associated with printing updated driver training rules). Any changes related to the jurisdiction transfer that require staff time will be accomplished by existing personnel and we therefore do not expect this rule to have a significant impact on the agency budget.

While new rule language clarifies that records regarding training of instructors and training managers must be maintained for three years, if a school is not currently meeting the requirements, there could be minimal costs with associated record

keeping. For driver training enterprises that are being brought into the jurisdiction of the Department of Public Safety from the Department of Education, it is likely that the information required to be maintained is already kept by the public schools. Adjustment by existing personnel to change record keeping organization and practices may be needed to meet the requirements of this rule.
