This rule filing is based upon a five-year R.C. 119.032 rule review prompted by legislation which transfers jurisdiction over driver education courses in high schools from the Department of Education to the Department of Public Safety. As a result of the review, it was determined that the rule did not require changes with regard to the change in jurisdiction.

While the change in jurisdiction from the Department of Education to the Ohio Department of Public Safety involves costs, implementing this rule is not expected to impact the agency budget beyond the cost stated in Rule 4501-7-01 (This is the cost associated with printing updated driver training rules). Any changes related to the jurisdiction transfer that require staff time will be accomplished by existing personnel and we therefore do not expect this rule to have a significant impact on the agency budget.

Purchasing new signs or converting existing signs for vehicles will likely be a new expense for a school system. The cost for signs for the cars is approximately \$200-250 each. To determine costs we contacted several sign companies for estimates and several schools regarding their experience in purchasing motor vehicles signage. Staff time that might be required for an employee to accompany a trooper during an inspection would be handled by existing personnel.
