Language is being added to paragraph (F) to further clarify the placement of the signs and required visibility of those signs. Paragraphs (H)(1) and (H)(2) are proposed for amendment to replace biennial with annual to clarify current business practice. Paragraph (H)(3) is proposed to include the requirement of maintaining proof of the vehicle inspections.
