This rule is being filed pursuant to a completed R.C. 119.032 review. This rule is proposed to replace existing rule 4501-7-28 due to Legislative Service Commission's fifty percent guideline. It is estimated that changes to the rule strike approximately half of the existing text while adding a comparable amount of new text. This rule number is simultaneously being proposed for rescission.

of the proposed rule; If the rule type is RESCISSION, NEW or NO CHANGE, then summarize the content of the rule:

The rule sets forth the training and curriculum requirements for each CDL school. The rule addresses the number of hours to be provided and specific topics for the classroom, range and road training. The rule addresses the ratio of instructors to students when training on the range and the location of the instructor during road training. Changes to this new rule address materials incorporated by reference and separation of training for class "A" and class "B" commercial licenses. Paragraphs (J) and (K) are designated for curriculum requirements for class "A." Paragraphs (L) and (M) are designated for curriculum requirements for class "B" training. Additional changes include that a school may offer training in either classification or both. Language is clarified that instructors shall directly supervise the students, students shall only be taught by licensed instructors, and instructors shall only act under the authority and guidance of a licensed school.

This rule incorporates "Code of Federal Regulations, Title 49, part 380," "Code of Federal Regulations, Title 49, part 383," "Code of Federal Regulations, Title 49, part 391,"and "Code of Federal Regulations, Title 49, part 395." To comply with sections 121.71 to 121.74 of the Revised Code, these materials are fully addressed in paragraph (SS) of rule 4501-7-01, which provides full citation, date/version of the materials, and availability.
