This rule sets forth the ability of the Director of Public Safety to take action against an applicant or licensee when the director has determined that provisions of Chapter 4501-7 of the OAC have been violated. The rule also addresses the licensee's rights under Chapter 119. of the Revised Code. This rule is being proposed as an amendment to include the new paragraph (D). The paragraph is being added to include actions being taken due to a licensee not paying for services they received by the department and/or fines imposed by the department.

It is estimated that the net impact will increase expenditures by \$92.50 per hour which includes a hearing examiner and court reporter for the purposes of the administrative hearings. Since the agency is responsible for providing administrative hearing rights to all licensees that may have violated provisions set forth in the rules, the fiscal year net impact of the department is difficult to determine. The actual costs are determined by the number of cases and the length of the hearings. The previous financial fiscal year 2014 the net impact was \$6,015.93 for this purpose.

Yes, administrative actions may be taken which may impose sanctions up to and including fines and/or suspension and revocation of a license if licensees fail to meet the requirements set forth in this rule.
