This rule is being filed to implement statutory changes set forth in HB 53, 131st General Assembly.

The proposed rule requires the business to be properly licensed before advertising for business. The rule also sets forth the requirements for the advertisements to be accurate and not contain information that may be misleading. The proposed rule prohibits the enterprises from advertising and implying endorsements by agencies or other businesses that are erroneous. The rule also prohibits the enterprises from stating employment shall result from a person applying for a position. Additionally, the rule prohibits enterprises from advertising in driver license exam stations.
