It is estimated that the net impact will increase expenditures by \$39.68 per hour to review records and complete investigations. The department requires an information technology security consultant to review the reports generated by the online provider during an inspection or investigation. The fiscal year net impact of the department is difficult to determine. The inspection/investigation will be based on the amount of time field staff and /or security personnel will need to review specific information. Each inspection and investigation will vary depending on the specifics of the complaint and/or volume of records obtained and reviewed.

The expenditures are appropriated through the 7036 fund (Highway Transportation Fund), ALI 761321 under Information and Education Operating.
