This rule, which replaces 4501:1-1-21 that is simultaneously being rescinded, is being proposed to update the lists of documents acceptable as proof of identity and to add proof of residency requirements during application for a driver's license, commercial driver's license, and identification card.

This rule provides requirements for the acceptable identification to be submitted along with an application for a temporary permit, driver's license, commercial driver's license, motorcycle operator's license, or state identification card. Proposed amendments add: 1) language that requires applicants to provide proof of residency, specifies the information that is required, and the documents which will be accepted; 2) clarifies social security number requirements; and 3) sets forth the criteria for issuance of duplicate licenses.
