This rule sets forth the documents necessary to establish a person#s identity and eligibility for obtaining an Ohio driver#s license, identification card or related BMV issued credential. The necessary documents are used to verify the person#s: (1) full legal name, (2) date of birth, (3) social security number, (4) United States citizenship or legal presence in the United States, and (5) residence address within the State of Ohio. This rule removes references to lists of #primary documents# and #secondary documents# and specifies what source documents are needed to establish each of the five (5) separate categories noted above. The rule also: sets forth a list of supplemental documents that may be considered if the source documents presented are not sufficient and permits the Registrar of Motor Vehicles to authorize acceptance of offender release cards from the United States Probation Department under certain circumstances. The amendment also requires permanent residents to produce their permanent resident documents (USCIS I-551) upon every credential renewal.
