This rule implements section 4501.81 of the Revised Code, which requires the Registrar of motor vehicles to establish the Ohio next of kin database.

This rule is amended in paragraph (B) to provide that an application for entry in the Ohio next of kin database shall be furnished to individuals who make application for an initial or renewal license or state identification card and that such applications may be returned to all bureau offices and deputy registrar agenices without charge. Additionally, a website address was corrected in paragraph (C), the application form was described in paragraph (D), and finally, punctuation was corrected, and terms for the applicant, the contact person, and the application form were made consistent throughout the rule.
