This rule is proposed to implement recent changes to section 4517.05 of the Revised Code as set forth in H.B. 245, 129th General Assembly.

This rule establishes that every applicant for a used motor vehicle dealer license is required to provide evidence that the applicant completed a training course presented by an authorized training course provider pursuant to section 4517.05 of the Revised Code.

No, this rule, in and of itself does not require prior authorization to engage in or operate a line of business; however, in accordance with other provisions of O.A.C. Chapter 4501:1-3 and R.C. Chapter 4517., persons who wish to become used motor vehicle dealers shall be licensed prior to engaging in business and providing evidence of the training mandated in R.C. 4517.05 is part of the licensing approval process.

B.) Does this rule impose a criminal penalty, a civil penalty, or another sanction, or create a cause of action, for failure to comply with its terms? **Yes**

Yes, failure to comply with the requirement to provide evidence of the training mandated in R.C.4517.05 may result in an application for a used motor vehicle dealer's license to be denied or rejected.

C.) Does this rule require specific expenditures or the report of information as a condition of compliance? **Yes**

Yes, in order to obtain a used motor vehicle dealer's license, a certificate of completion for the training course must be presented at the time of application.
