The rule provides that an applicant for a license must show that the business for which a license is sought is equipped with a sign, provides requirements for a suitable sign, and prohibits physical alteration of an established place of business that would bring it out of compliance with the requirements of R.C. Chapter 4517 by a motor vehicle dealer or auction owner.
