This rule sets forth criteria in which the Registrar shall deny applications for motor vehicle dealer licenses for felony convictions unrelated to the licensure or regulation of motor vehicle sales if such conviction occurred prior to December 8, 1996. Amended language eliminates the current "December 8, 1996" date, and replaces it with a ten-year timeframe.
