4501:1-3-09 (Registrar shall deny license) sets forth the criteria by which the registrar shall deny applications for motor vehicle licesnes for felonly convictions. It requires the registrar to deny an applicant a dealer's license if the applicant has been convicted of a felony related to the selling, taxing, licensing, or regulation of sales of motor vehicles within ten years of the date of application. This rule was amended to properly address materials (agency applications) incorporated by reference.
