This rule is proposed for rescission and simultaneous adoption under this same rule number. However, failure to comply with the requirements set forth in this rule may have resulted in denial of a renewal application or in administrative action up to and including revocation of an existing license. Further, in accordance with section 4517.99 of the Revised Code, unless otherwise specifically provided in Chapter 4517. of the Revised Code, whoever violates rules promulgated under sections 4517.01 to 4517.45 of the Revised Code is guilty of a misdemeanor of the fourth degree.

This rule is proposed for rescission and simultaneous adoption under this same rule number. This rule required licensees to maintain compliance of all physical requirements of an established place of business for a motor vehicle leasing dealer's license.
