This rule is proposed for rescission and simultaneous adoption under this same rule number. However, failure to comply with the requirements set forth in this rule may have resulted in denial of an initial or renewal application or in administrative action up to and including revocation of an existing license. Further, in accordance with section 4517.99 of the Revised Code, unless otherwise specifically provided in Chapter 4517. of the Revised Code, whoever violates rules promulgated under sections 4517.01 to 4517.45 of the Revised Code is guilty of a misdemeanor of the fourth degree.

C.) Does this rule require specific expenditures or the report of information as a condition of compliance? Yes

This rule is proposed for rescission and simultaneous adoption under this same rule number. However, this rule required licensees to maintain compliance of all physical requirements of an established place of business for a motor vehicle auction owner's license. Licensees may expect adverse impact in the day to day operation costs of maintaining a facility that meets the requirements.
