This rule filing is based on a scheduled R.C.119.032 five-year rule review of Ohio Administrative Code Chapter 4501:1-5. Based on the review, Rules 4501:1-5-02, -03, and -04 which cover obtaining scheduling information for the Motor Vehicle Dealers Board meetings are proposed for rescission and the information in those rules has been deleted where unnecessary, reorganized, renumbered, condensed, and incorporated in this proposed new rule in Ohio Administrative Code Chapter 4501:1-3. The purpose of this reorganization is to simplify, clarify, and streamline the Motor Vehicle Dealers Board rules, and to provide better public access to the

rules by combining them in one Administrative Code chapter.

The rule provides methods for ascertaining the time and place of any Motor Vehicle Dealers Board individual, regularly scheduled or individual, special meetings, for obtaining meeting notification on a yearly basis, and for news media to obtain advance notice of all Motor Vehicle Dealers Board special meetings and regarding notice in the event of a special meeting of an emergency nature.
