The BMV receives 50 cents from each vehicle registration renewed using a Self-Service Terminal. The BMV receives the entire Deputy Fee (\$3.50 to \$10.00 depending on the number of years for which the registration is issued) for a registration/renewal completed using our toll-free number or our website. This fee is retained by the Deputy Registrar License Agency if a customer chooses to renew in person. This brings in approximately \$4,478,249 annually.
