Page 2 Rule Number: 4501:1-7-12

This rule provides the process for issuance of collegiate license plates. The rule removes the existing requirement that colleges and universities provide an estimated number of plates to be sold. It also removes the requirement for submittal of a camera-ready logo image and replaces it with a requirement for submittal of a logo in a design format "as required by the registrar."
