This rule outlines the qualifications for certain specialized license plates for military personnel. This rule is being amended to define "reservist" and "veteran" in the same way that they are defined by the Ohio Department of Veterans Services. It is also being amended to reflect the correct end date of the Mission of 1982, to add a comment for the purpose of incorporating incorporate BMV Forms 4705 and 4508 by reference in new rule 4501:1-7-15, and to create rules for the issuance of service star license plates as required by section 4503.433 of the Ohio Revised Code.
