This rule filing is based on a scheduled R.C. 119.032 rule review of Ohio Administrative Code Chapter 4501:1-8. The rule is proposed for change to update the rule amplification statute listing.

The rule provides that credit for the unused portion of the registration of an

apportioned vehicle which has been deleted from a fleet, may be applied to vehicles being added, or additional weight being added to one or more of the existing carrier's vehicles, provided the credit is used within the same registration year. It also provides that when transmitting funds between jurisdictions, Ohio will allow a maximum five-dollar error variance per individual carrier account. No proposed changes to the existing rule language are being proposed.
