This rule filing is based on a R.C. 119.032 rule review of Ohio Administrative Code Chapter 4501:2-10. Proposed changes are to update and to enhance clarity.

Proposed changes include addition of the terms "Interpol", "LEADS owned equipment", and "USNCB (United States National Central Bureau) and their

definitions. Changes also include an update to the definition for the term "LEADS workstation" and an update of the term "National law enforcement telecommunications system (NLETS)" to "NLETS (International Justice and Public Safety Information Sharing Network)". Proposed changes include addition of further defining language to the definitions of the terms "serious misdemeanors", "terminal", "terminal agency", and "validation."
